• CTE – Family & Consumer Sciences Program

Kent Victor introduced the CTE Family & Consumer Sciences Program and teachers Tiffany Sahagian, Stacey Anderson, and Karen Pehl. A video was shared about all the activities happening the electives of Culinary Foundations, Life on Your Own, Fashion & Apparel, Impact, and Family Health. Mrs. Pehl explained the progression of these programs and how their projects are community based. Mrs. Sahagian gave an example of the efforts of the Impact club with fundraising and giving back to their schools and world-wide. Students gave the board a summary of what Family & Consumer Science classes they are involved in and what inspires them to help others. Karen gave examples of life skills being taught. The students praised the life skills being taught and how important it is for their future and has made a difference in their outlook of their futures. Mrs. Sahagian shared the vision on the upcoming Health II class. The board questioned students on their experiences of fundraising and donating and what they took away from their Life Skills classes.
