• Budget Update - April

Jim Frey reviewed and discussed items on the April budget containing a summary of financial status, enrollment, general fund comparative, and revenues and expenditures.

Jim Frey identified the budget contingencies for the Fisher Elementary Design Development. The board discussed alternate bids and plans moving forward.

### 8. Board Work Session

Secondary School Improvement Plans (SIP's)

Jim Frey introduced the Secondary Principals and explained how they will be presenting their School Improvement Plans (SIP) to the board. High School Principal, Ian Freeman spoke about the achievement

gap and how to be responsive to the achievement gap. Ian talked about the interventions and professional development being used to support students, and shared some of the challenges of providing assistance to student needs. High School Assistant Principal, Lisa McKeen spoke about the teaming efforts between administrators, counselors, teachers, interventionists, and special programs to support students in closing the achievement gap. Ian shared a story about a student engaged in the Round-About program as well as a CTE engineering program and how he successfully progressed from middle school to high school with these programs, along with caring school staff. Middle School Assistant Principal, Patrick McClure spoke to the question if there are similar programs at the middle school. Patrick explained that there are similar programs. However, the support is different based on core class requirements, but that the middle school is currently expanding more support programs.

Lynden Middle School Principal, Molly Mitchell-Mumma explained the focus on instruction (SIOP, 5D, and improving other Tier 1 Instruction). Molly spoke about collaboration of lesson plans between schools and outside support entities. Molly & Patrick shared a success story of a teacher utilizing a collaborative lesson plan and how it encouraged the students to engage more in the class. Patrick shared a student success story about how the student's teacher based her instructional practices on the collaborative lesson planning and it resulted in a positive outcome for the student. Molly and Patrick addressed the challenges that are barriers to improving instruction.

Lynden Academy Principal, Chris Jorgensen provided information about how work is taking place in the Professional Learning Community (PLC) to establish regular collaboration time and the vision for lesson collaboration. Chris also shared about some of their intervention programs. Lynden Academy Teacher, Ellie Mink provided examples of how Lynden Academy staff is sharing lesson plans and the positive impact on both students and staff.
